**Course Name** Provide cardiopulmonary resuscitation **Code** HLTAID001

**Description** **Provide cardiopulmonary resuscitation** is a nationally recognised unit that describes the skills and knowledge required to provide cardiopulmonary resuscitation (CPR) in line with the Australian Resuscitation Council (ARC) Guidelines This unit applies to all workers who may be required to provide CPR in a range of situations, including community and workplace settings .

### Course Delivery

**Duration** 1 x 3 hour face to face session  
Pre-Course Assessment **MUST** be completed prior to attendance

- Elements**
- 1. Respond to an emergency situation**
    - 1.1 Recognise an emergency situation
    - 1.2 Identify, assess and minimise immediate hazards to health and safety of self and others
    - 1.3 Assess the casualty and recognise the need for CPR
    - 1.4 Seek assistance from emergency response services
  - 2. Perform CPR procedures**
    - 2.1 Perform cardiopulmonary resuscitation in accordance with ARC guidelines
    - 2.2 Display respectful behaviour towards casualty
    - 2.3 Operate automated external defibrillator (AED) according to manufacturer's instructions
  - 3. Communicate details of the incident**
    - 3.1 Accurately convey incident details to emergency response services
    - 3.2 Report details of incident to workplace supervisor as appropriate
    - 3.3 Maintain confidentiality of records and information in line with statutory and/or organisational policies

**Delivery** Training delivery will focus on facilitation of adult learning by contextualizing learning programs to suite the individual learner needs, reasonable adjustment will be used to accommodate varying communication and learning styles.

- Assessment** All assessment criteria must be met for a learners to be deemed as competent:
- Practical assessment:**
- It is an assessment requirement that learners are able to get down on the floor and perform simulated CPR for an extended period of time
  - participation in group and individual case scenarios
  - demonstration on CPR in line with ARC guidelines
  - demonstrate use of an AED
- Written assessment:**
